Subject : Regarding the grant of recognition certificate to schools as per section 18 of the Right of Children to Free and Compulsory Education Act, 2009 and under rule 11(4) of the Right of Children to Free and Compulsory Education Rules, 2011.

In connection with your application and subsequent correspondence and inspection dated 22.01.2025. I, The Education Officer (Primary) Zilla Parishad, Nanded, hereby grant temporary approval to Indira International Public School, Nanded, Taluka and Dist. Nanded, for a period of three years from 22.05.2024 to 21.05.2027.

The above approval is subject to the fulfillment of the following conditions:-

1. The period of recognition will not be extended and there will be no obligation to grant recognition or affiliation after class VIII under any circumstances.
2. The school shall comply with the provisions of the Children's Right to Free and Compulsory Education Act, 2009 (Annexure One) and the Maharashtra Children's Right to Free and Compulsory Education Rules, 2011 (Annexure Two).
3. The school shall admit children from the weaker sections and disadvantaged groups in the Vicinity in the class first up to a minimum of 25% of the number of students in that class and shall provide them with free and compulsory education till the completion of primary education, provided further that this standard shall also be followed in the case of pre-primary classes.
4. The school shall be provide a separate bank account for the purpose of receiving reimbursement in accordance with Section 12(2) of the Act for the children referred to in paragraph 3.

5. The institution/school will not charge any capitation fee and will not force the child or his or her parents or guardians to undergo any screening process.
6. No child shall be denied admission to school on the grounds of lack of proof of age, religion, caste or creed, place of birth or any of these.
7. (One) Child admitted to school shall not be retained in the same grade in which he is enrolled or shall not be expelled from school until he has completed his primary education.
(Two) No child shall be subjected to physical punishment or mental harassment.
(Three) No child shall be required to pass any board examination until the completion of primary education.
(Four) Every child who has completed primary education shall be given a certificate as prescribed under rule 23.
(Five) Students with disabilities/special needs shall be included in accordance with the provisions of the Act.
(Six) Teachers holding the minimum qualification prescribed under section 23 (1) of the Act shall be appointed. Provided further that, teachers who do not hold the minimum qualification on the date of commencement of the Act shall have to acquire such minimum qualification within a period of 5 years.
(Seven) The teacher shall perform his/her duties as specified in section 24 (1) of the Act and
(Eight) The school shall ensure that the teacher does not engage himself/herself in private Tuition/coaching classes.
8. The school shall follow the curriculum prepared on the basis of the curriculum prescribed by the appropriate authority.
9. The school shall admit students in proportion to the facilities available in the school as stipulated in Section 19 of the Act.
10. The school shall comply with the standards and norms specified in Section 19 of the Act. The facilities available in the school at the time of the last inspection were as follows:-





- Area of school premises : 185800.00 sq. ft.
- Total Construction Area : 32000.00 sq. ft.
- Playground Area : 12000.00 sq. ft.
- Number of classrooms : 13
- Office-Store-Principal's Room :- 04
- Separate toilets for boys and girls with sufficient water for use and to keep the toilets clean and hygienic : YES.
- Drinking water facility : YES.
- The kitchen is available for cooking lunch : Not Applicable.
- Availability of teaching and learning materials/games and sports materials/library: Yes
- Reading materials are freely available : YES.

11. Unapproved classes or groups cannot be run in the name of the school, on the school premises or elsewhere.
12. The school building or other structure or playground shall be used only for the purpose of education and skill development.
13. The school is being run by a society registered under The Societies Registration Act, 1860 (21 of 1860) or the Bombay Public Trusts Act, 1950.
14. The school is not run for the benefit of any individual, group or association of individuals or any other person or for the purpose of earning any profit.
15. The accounts of the school should be audited and certified by a chartered accountant and proper accounts should be prepared as per the rules. A copy of each account should be sent to the District Education Officer every year.
16. The accreditation code given to your school is 27150107304. Please note that you should mention it while communicating with this office.
17. The school shall submit such reports and information as the Director of Education/District Education Officer may request from time to time or shall comply with such instructions as The Government or local authority may give to ensure the continuous fulfillment of the conditions of recognition of the school or to rectify any deficiencies in the functioning of the school.
18. Ensure that the registration of organizations if any to be renewed.

19. Other terms and conditions as per Annexure III are attached herewith.
20. Report is given subject to the inspection report given by the Investigating Officer.


